



# VILLAGE OF KRONENWETTER

## 2023 PROPERTY TAX INFORMATION

### WHEN:

- **The first property tax installment payment is due by January 31, 2024.** Taxes can also be paid in full by January 31, 2024.
- If paying in installments, the second property tax installment payment is due by July 31, 2024. **This second payment MUST be paid to the Marathon County Treasurer, 500 Forest St., Wausau, WI 54403**

### HOW:

- **CHECK** - Please make checks payable to: Village of Kronenwetter. **Make sure they are LEGIBLY written with black ink.**
- **ESCROW CHECK** - Any arrangements with an escrow agent are between you and that agent. If you are paying with an escrow check, please ensure your check is properly endorsed. Checks made payable jointly to you and the Village must be endorsed by YOU and submitted to the Village. If an escrow check is more than the amount due, the Village will issue a refund within 10 business days made out to the owner on record.
- **CASH - In-person cash payments** are accepted at the Kronenwetter Municipal Center. Refunds for overpayments exceeding \$20 will be issued by check and processed within 10 business days.
- **CREDIT/DEBIT CARD** - The Village uses AllPaid for processing credit and debit card payments. Visa, MasterCard, American Express and Discover cards are accepted. **There is a 2.95% non-refundable convenience fee charged on ALL credit and debit card transactions.**

### WHERE:

- **MAIL** - Payments can be mailed to the Village at 1582 Kronenwetter Drive, Kronenwetter, WI 54455. Att: Sarah Fisher. Please include your payment stub.
- **TAX PAYMENTS POSTMARKED IN 2023 WILL BE RECEIVED IN 2023.**
- **DROP BOX** - The Village has a secure drop box located in the front of the Municipal Center entryway.
- **IN-PERSON** - Village staff will accept payments Monday-Friday, Dec. 15, 2023 - Jan. 31, 2024 from 8 a.m. to 4 p.m. **EXCEPTIONS:** Dec. 28, 29, Jan. 31 - 7:30 a.m. to 5 p.m.
  - **The Municipal Center will be closed Dec. 22, 25, 2023 and Jan. 1, 2024.**
- **LOCAL BANKS** - You DO NOT need an account to use these pay stations.
  - **INCREDIBLE BANK** - 1130 E. Grand Avenue, Rothschild. Lobby Hours: M-F 8:30 a.m. - 5 p.m. Drive Up Hours: M-F 8 a.m. - 5:30 p.m. Sat. 9 a.m. to 12. p.m.
  - **VALLEY COMMUNITIES CREDIT UNION** - 2290 County Road X, Kronenwetter. Lobby Hours: M-TH 8:30 a.m. - 4:30 p.m. Friday 8:30 a.m. - 6 p.m.

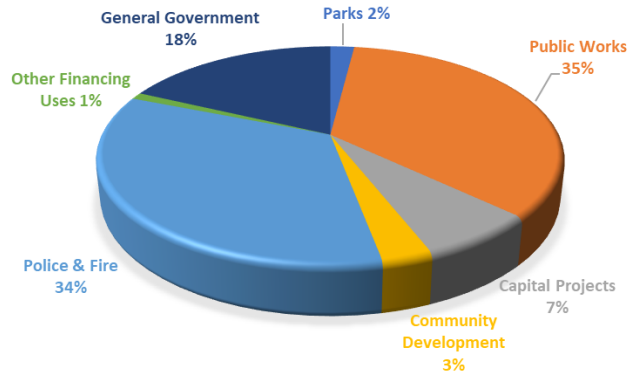

## TAX CREDITS - ARE YOU ELIGIBLE?

- Lottery Credit** - If your home is your primary residence and you have occupied it since January 1, 2023, you are entitled to this credit. If it doesn't appear on your tax bill, contact Account Clerk Sarah Fisher at 715-693-4200 ext. 1723 or [sfisher@kronenwetter.org](mailto:sfisher@kronenwetter.org) for an application.



MORE INFO

- First Dollar Credit** - Every taxable improved property qualifies. It will automatically be applied to your tax bill. This credit is automatically applied to all qualifying properties.

## DOG LICENSING

TO LICENSE YOUR PET, YOU WILL NEED :  
(There is no form to fill out.)



MORE INFO

- Dog license fee (see the chart to the right)
  - The fee can be paid in-person, online or mailed to the Municipal Center. (1582 Kronenwetter Drive, Kronenwetter, WI 54455)
  - If the fee is paid online, a \$2.50 convenience fee will be added. The fee covers the cost of mailing the licenses, tag and rabies certificate back to you.
  - If paying by credit/debit card, there is a \$1.50 service fee in addition to the above-mentioned \$2.50 fee.
  - If paying by mail or drop box, please include a current phone number along with a self-addressed, stamped envelope for us to mail the tag and rabies vaccination certificate back to you.
- Current rabies vaccination certificate
  - This must be submitted to the Village in order to complete the licensing process.
  - This can be submitted in-person or a copy can be sent in the mail or email. ([doginfo@kronenwetter.org](mailto:doginfo@kronenwetter.org))

## LICENSE PAYMENTS MUST BE PAID SEPARATELY FROM TAX PAYMENTS.

(DO NOT WRITE ONE CHECK FOR TAXES AND LICENSES.)

LICENSE TYPE	IN PERSON/MAIL	ONLINE
Unaltered Adult Dog (6 months and older)	\$12.00	\$14.50
Neutered/Spayed Adult Dog (6 months and older)	\$7.00	\$9.50
Service Dog	\$0	N/A

Service dogs must be registered in-person!

A \$5 late fee is added for licenses issued after March 31 of the license year. The late fee does not apply to new residents or new pets.
